Puppy Purchase Contract

This contract is between Christa McCoy, herein after referred to as "Sellers" and/or "Breeders" and \_\_\_\_\_, herein after referred to as "Buyer."

In consideration of payment in full of the purchase price of \_\_\_\_\_ by Buyer to Sellers, Sellers agrees to transfer to Buyer, subject to the terms and conditions contained in this contract, the ownership of one Male/Female Labrador Retriever puppy, herein after referred to as the "Puppy" (regardless of age), from the mating of the sire and dam identified below.

## PAYMENT

A \$200 non-refundable deposit will hold the BUYER'S pick. First pick will go to the first deposit received and so on. The remainder of the purchase price is due when the puppies are 7 weeks of age. The BUYER can pick up the puppy when it reaches 7 weeks of age or the puppy can be shipped to any major airport at 8 weeks of age. **Puppies can be shipped to their new homes at 8 weeks of age.** If for any reason the BUYER decides to forfeit their puppy, the deposit can be transferred to a future litter. The deposit is refundable if the sex/color requested is not available.

## SHIPPING

Puppies can be shipped at eight weeks of age.

Air Cargo - Shipping costs via air are approximately \$450. This includes air freight charges, crate, health certificate, and transportation to the airport. Shipping your puppy by air is safe and fast.

Vagabond Hound, Dog and Puppy Transportation - Vagabond Hound is a door to door shipping service. They deliver anywhere in the continental US and make one trip through the US once a month. Pickup in our area is around the first of the month. Shipping costs for puppies are \$325 to be paid when the puppy arrives. #### GUARANTEE

It is understood that, at the time of sale, this puppy has been evaluated by the breeder with respect to other representatives of the breed at approximately the same age and has been determined to be structurally and temperamentally suited to be a companion, hunting, and/or obedience dog. This does not necessarily imply that the dog is of breeding or show quality. This puppy is guaranteed to be healthy upon delivery to the buyer, and a full refund will be given for any puppy found to be unhealthy within 30 days of purchase, provided the following is met:

The puppy must be examined by a veterinarian of the buyer's choice within THREE (3) business days. If the puppy is found to be ill, the breeder is to be notified within 24 hours and a refund of the purchase price will follow the return of the puppy and all papers to the breeder, including a written statement from the attending veterinarian stating the dog's condition. During the remainder of the initial 30-day period, the buyer shall maintain the puppy's schedule of inoculations and any other basic healthcare recommended by their veterinarian. If the BUYER is at fault for the puppy's illness (i.e. poisoning, injury, etc) this guarantee is VOID. The next set of puppy shots is due on \_\_\_\_\_. We recommend that you discuss heartworm medicines with your Vet.

We guarantee that each puppy will be certified by the Orthopedic Foundation for Animals (OFA) and the Canine Eye Registration Foundation (CERF) up to 26 months of age. In the instance that it is not, a replacement will be given as soon as one is available, or a refund of 100% of the purchase price will be given at the breeder's earliest opportunity. If the dog has been bred or is over the age of 26 months this portion of the agreement is VOIDED. It is not necessary to return the dog to the breeder or have the dog destroyed to collect on this agreement; however, the dog must be neutered or spayed with proof of same provided to the breeder in writing from your veterinarian before a refund is issued.

The puppy is guaranteed to not be CNM (Centronuclear Myopathy) or EIC (Exercise Induced Collapse) affected. At least one parent of every litter will be certified clear of these disorders. A clear dog can be bred to a carrier and not produce any affected puppies. No two carriers should be bred. Visit these websites for more information:

**VACCINATIONS AND HEALTH CARE:**

All appropriate shots for the PUPPY'S age have been given, and a record of this vaccination history is supplied. The BUYER agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations, and any other common healthcare necessary to assure good health. The BUYER agrees to feed the puppy only quality age appropriate dog food. We use and recommend Diamond brand dog food.

**RETURN AGREEMENT:**

The BUYER hereby agrees that if at any time the BUYER cannot take proper care of this Labrador Retriever, the BUYER must contact the BREEDER and the BREEDER will have the first choice to either: (a) take the Labrador back or (b) assist the BUYER in finding a suitable home for the Labrador. The BREEDER reserves the right to take back the puppy if it is found that the puppy is being abused or neglected (i.e. no food or water provided, physically abused, etc) with no refund of the purchase price to the BUYER.

*The BREEDER neither makes or implies any warranties or guarantees, express or implied, other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the Breeder and Buyer with respect to this sale. Therefore Buyer's signature below indicates that he/she has read, agrees and does understands all the conditions of the Sales Agreement and Contract of Sale.*
